The Minnesota Pollution Control Agency (MPCA) is distributing this Environmental Assessment Worksheet (EAW) for a 30-day review and comment period pursuant to the Environmental Quality Board (EQB) rules. The MPCA uses the EAW and any comments received to evaluate the potential for significant environmental effects from the project and decide on the need for an Environmental Impact Statement (EIS).

Description of proposed project

Curbside Waste Inc. intends to transfer up to 500,000 cubic yards/year of outsourced mixed municipal solid waste, construction and demolition waste, yard waste, source separated organics, and single stream recycling at the existing transfer station (Project) in the City of Dayton at 18150 118th Avenue North. No processing or permanent storage of waste would occur at the transfer station.
